General membership meeting on Jan. 8, 2019 (moved to the second Tuesday as the first Tuesday is Jan. 1). 6:30 for dinner, 7:30 for meeting.

Totem General Meetings are the 1st Tuesday of each month (unless otherwise noted), at 6:30 for dinner & 7:30 call to order.

Board Meetings are the 3rd Tuesday of each month at 6:30 pm. at the club house. All members are welcome to attend board meetings.



The board and officers have reviewed [proposed amendments](#) to our bylaws and recommend we vote to accept them. For reference, [view the current bylaws here](#). Here's a quick review of the proposed amendments:

- Added a table of contents
- Added titles to each section
- Clarified when "year" means calendar year versus a 12-month period
- Switched the order of articles on "Officers and Duties" and "Meetings"
- Clarified what constitutes a quorum for various meetings
- Added that if membership is inactive (a demit), the burgee must be returned to TYC
- Clarified that election of officers and board will be conducted by the yeoman (see Article VII Section 1)
- Cleaned up language for consistency throughout (i.e. Board of Trustees v. Directors is now always Trustees, and Membership Directory v. Yearbook) and pronouns gender-neutral
- Gave the board the option to seek an outside audit of financial records -- this is to protect the club and the purser (see Article IX Section 4)
- Condensed Uniforms and Devices into a single section

Under the Jan. 2018 bylaws, sharing the proposed amendments via email prior to our next general member meeting (on Dec. 4) constitutes the advance reading requirement.

These By-Laws may be amended by a two-thirds vote of membership present and voting at any regular meeting after such amendments have been read at a previous meeting. Sending the proposed amendment(s) in writing to the membership prior to the meeting at which introduced shall satisfy the requirement for a first reading at the meeting.


